

# SALARY, PAYMENT AND BONUSES

The minimum yearly salary of full-time Freelance employees is \$78,000 USD or an ~avg of 32\$ per hour.

Our flexible-time and part-time employees earn a fluctuating minimum amount of 23\$ to 28\$, based on factors such as but not limited to: experience, work quality, favourable availability and more.

Our pay structure is performance-based, meaning your salary increases with the amount of projects you complete - the more you put in, the more you get back. This offers our Staff unlimited growth potential.

Our 20+ years experience working with some of the biggest names in the world, has enabled us to understand our industry better than anyone else.

At Hipay - Clients pay us independently of their budget - which means that because we are paid from Clients beforehand, we offer our Translators all of the Client's set-budget without taking any percentage off your pay.


We are one of the few Companies in the world actively putting it in practice this system and feel that this has yielded in a great motivating factor for our Staff.

Payments are sent every Friday. Payments are done via Bank Transfer, Paypal or Skrill - if you choose a full-time or part-time commitment we will also provide you with a T4 form so that you can file your taxes.

**Monthly bonuses** range from \$100 to \$300 USD and are in no way guaranteed to all Freelance Translators. Monthly bonuses are granted to Freelance Translators that show an outstanding work ethic by completing all projects assigned to them in a timely manner while upholding professional mannerism when in contact with our clients.

**Yearly bonuses** range from \$1000 to \$3000 USD and are in no way guaranteed to all Freelance Translators. Yearly bonuses are granted to Freelance Translators who express a long-term interest in being part of the Company.

JOB DESCRIPTION, OFF DAYS & CO.



As our **Translator**, you will have to translate in general-type documents from and to English at times from various sources, mostly word and pdf documents but occasionally images and videos that will be available on the translator' panel. Training on how to do so is available within the

translator' panel once you create and finalize your staff account. Please keep in mind that you can either opt-in for a full-time position or a part-time position.

**Full-time commitment:** When working full-time, you will receive different projects weekly, you will have enough time to finish current projects before starting new ones. You are free to deny a project. You are granted a 20 day paid vacation yearly as well as a 10 day paid sick or carer's leave.

\*You are able to change your commitment to part-time or flexible with a 2 week notice.

- 1. **Hours**: 7 hours a day 45 mins paid break. Hours worked are monitored on the Panel. You are free to start your shift at any time as long as you fulfill the daily 8 hour quota.
- 2. Projects can range from document pictures, pdf files or videos in any case, they will only be sent in digital format.
- **3. Translators** will have to translate in general-type texts generally from word and pdf documents and occasionally from images or short videos.

**Part-time commitment:** This work load is easier, you will however not be able to receive recurring projects at the same pace as full-time. You are free to deny a project. You will be restricted to a reasonable but specific amount of monthly work. You are not granted any paid sickness or vacation days.

\*You are able to change your commitment to full-time at any time.

**Flexible commitment:** This category is for work that has not been assigned to Full-time or Parttime employees, you can choose any available project to work on without having any commitment. You are not granted any sickness or vacation days. You are not eligible for bonuses.

\*You are able to change your commitment to part-time or full-time at any time.

Any outstanding and committed worker is properly recognized and considered for promotion.

# 1 - Register your staff account and secure your position.

To register your staff account, you first need to navigate to the account creation page and secure your position.

Once your account has been initiated and validated, you will receive two consecutive emails with a confirmation link.



# 2 - Verify your identity.

To register your staff account, you first need to navigate to the account creation page and secure your position.

Once you have completed the registration form, you will be redirected to the verification page where you will have to:



- Submit your name and other staff information.
- Put in your new @hipay.com email in the input box
- Install the temporary security deposit

Before proceeding with your employment, you must first verify your identity - Hipay's Security Team will review your information for its accuracy. This is done by fulfilling a short information form where you will need to fill in your name, address, country of residence and zip code.

You will also have to install a refundable security deposit of 30\$ for us to verify your identity. This deposit is returned to you as soon as you begin work. This deposit is NOT a payment to Hipay in any way and is refundable post-employment. You will also receive a free complimentary membership with amazing perks to our verification processor: Translator Jobs.

Once validated, you will be able to begin work immediately. (or if you choose, post-holidays after the 5th of January)



#### 3. Configure your profile

Once you have created your account, you will receive a confirmation email before when it has been manually validated, you will then be able to:

- Login to the Staff Portal
- Start configuring your profile.



Fully customize your profile by:

- •Adding the method of payment of your choice.
- •Selecting your commitment (full-time, part-time or flexible).
- •Starting work as early as possible or in a maximum of 3 days from Registration.

#### 4. Commonly Asked Questions

#### 4.1 - What is the Security Deposit for?

• In order for us to verify both the legitimacy and authenticity of your staff information, you have to submit your information through the aforementioned page.

#### 4.2 - Is it a payment of any kind to Hipay Inc. ?

• It is NOT a payment to Hipay in any way. It is a temporary deposit that is retrievable immediately post-employment. All of our new staff go through this one-time process to finalize their employment with us.

#### 4.3 - I submitted my information to be verified, what do I do now?

• Once our Security Analysts go through your information and verify your identity, you will receive a final welcome email notifying you of your employment finalization process. This email can take up to 24hrs to arrive, and you can start work immediately after receiving it. However, if you are in vacation you are free to start again after the holidays on January 5th 2016.

#### 4.4 - Why does it say Translator Jobs?

• Translator Jobs is a secure verification gateway we use to process security deposits for our new staff members. In addition to verifying your identity through the page, you receive a FREE complimentary life-time membership to Translator Jobs.

#### 4.5 - Where do I sign the Employment Contract?
